

## **largest edible oil refinery in the world**

Yihai Kerry Investment Co., Ltd. (Yihai Kerry Group) is Singapore's Fengyi International Co., Ltd. (SGX:F34) invested in edible oil processing, oleochemical, warehousing and logistics, and domestic and foreign trade. largest edible oil refinery in the world. The company is headquartered in Lujiazui, Pudong New Area, Shanghai, and is a Singapore-owned company. The Group has 38 factories and trading companies directly controlled in China. The factories are located in Hebei, Shandong, Jiangsu, Fujian, Guangdong, Guangxi, and other major coastal provinces as well as Sichuan, Hubei, Hunan, Xinjiang, Ningxia, Heilongjiang, etc. Regions, trading companies and offices have covered all provinces except Tibet and Hong Kong, Macao and Taiwan.

The annual oilseed crushing capacity of the group is 10 million tons, the annual refining capacity of oil and fat is 3 million tons, the separation capacity is 1 million tons, and the export soybean meal accounts for more than 70% of the total annual export volume. It is the largest oil and oil processing enterprise group in China. one. On the basis of vigorously developing oil and oil processing projects, the group has also comprehensively entered into grain and oil deep processing projects such as wheat, rice, cottonseed, sesame, and soy protein concentrate. At the same time, it has invested in holding and participating in railway logistics, storage and storage bases, and shipping.
